<u>Organizational Background:</u> The mission of the Alpine Watershed Group (AWG) is to preserve and enhance the natural system functions of Alpine County's watersheds for future generations. AWG's role is to monitor water quality, assist with needed restoration projects, and engage community participation in order to maintain healthy watershed systems. With the participation of a diverse stakeholder group, the organization builds community collaboration around watershed management and restoration efforts. Since 2001, AWG has been serving a critical role in collaborative watershed planning and restoration in Alpine County.

Since 1993, the Sierra Nevada Alliance has been protecting and restoring Sierra lands, water, wildlife, and communities. We are a hub for stewardship of the Sierra Nevada, which we achieve by empowering and collaborating with our partners.

<u>Position Description:</u> This AmeriCorps position will be hosted by the Alpine Watershed Group and Sierra Nevada Alliance to serve some of California's most precious watersheds, Lake Tahoe and the five major headwater watersheds originating in Alpine County. Half of the member's time will serve AWG in Alpine County—California's least populated county, made

up of 95% public lands—and the other half will serve SNA in the Lake Tahoe watershed, the largest high alpine lake in the United States.

Monitoring and Outreach Specialist's primary focus at AWG is to assist with the various outreach platforms and recruit and coordinate volunteer involvement in AWG's watershed programs.

Sierra Nevada Alliance Projects:

The Sierra Nevada Alliance Volunteer and Outreach Coordinator will recruit and support volunteers for Sierra Nevada Alliance events, and program areas.

In addition, the member will support SNAP members by sending the weekly volunteer email, and managing the SNAP social media sites. They will lead the further development of the SNAP Alumni committee by planning and leading committee meetings and communicating with committee members.

They will manage the Alliance monthly webinar series by recruiting speakers, advertising the series, and managing the monthly webinars.

They will also support the Alliance's annual Wild and Scenic Film Festival by creating and sharing outreach materials, recruiting volunteers, viewing movies, and attaining resources for the silent auction.

They will represent the Sierra Nevada Alliance as part of the Take Care Tahoe Outreach Committee, the South Tahoe Environmental Education Committee, and the South Lake Tahoe Earth Day Committee. They will also represent Sierra Nevada Alliance at tabling outreach events throughout the year.

- Represent the Sierra Nevada Alliance at table and outreach events throughout the year.
- Help build the Alliance volunteer opportunities and community engagement
- Recruit and manage volunteers at events throughout the year
